President Mesmer led all present in the Pledge of Allegiance and called the meeting to order at 6:30 p.m.

Community Input: None.

Review and Possible Approval of the June 18th 2018 General Board Meeting Minutes: After the Board reviewed the June 18th, 2018 General Board Meeting Minutes, Director Kriss moved for approval as presented. Director Lalonde seconded; the motion passed unanimously.

Surfside Colony, Ltd. 2017-18 Year-End Reconciliation and Final June 2018 Billing: Clerk Montana presented the final 2017-18 year-end reconciliation (see attached) showing total actual expenses incurred by Surfside Colony Ltd. in fulfilling the 2017-18 Security and Maintenance Contract (excluding rent) of \$402,561 compared to total budgeted expenses of \$423,336. Accordingly, the difference of \$20,775 was used to reduce the recurring monthly June 2018 invoice of \$36,378 to \$15,603. After review and discussion, a motion was made as follows:

**MOTION:** Director Kriss moved to accept the 2017-18 Year-End Reconciliation as prepared, and to pay \$15,603 for final 2017-18 payment to Surfside Colony, Ltd. Director Lalonde seconded and the motion passed unanimously.

<u>Current Bills</u>: Clerk Montana presented check #3525 and check #'s 3532-37 in the amount of \$94,889.72 for final June 2018 year-end invoices as well as July 2018 invoices for administrative and Project Cost expenses, for review and signature. Checks were signed as submitted.

<u>Fund Balance and Clerk's Report:</u> Clerk Montana reported the fund balance as of July 23rd, 2018 to be \$832,046 and reviewed the trial balance with the Board. The Clerk also reviewed the monthly Surfside Colony project report with the Board. Candidate filing requirements were discussed.

<u>Possible Approval of CSDA Annual Conference Expense:</u> President Mesmer discussed the California Special District Annual Conference scheduled for Sept. 24<sup>th</sup> through 27<sup>th</sup> and requested funding approval for conference fees and travel expenses estimated to be not more than \$1,500. A motion was made and carried as follows:

**MOTION:** Director Kriss moved to fund fees and travel expenses for an estimated amount of \$1,500 or less in order for President Mesmer to attend the CSDA Annual Conference. Director Lalonde seconded and the motion passed unanimously.

<u>Board Member Items and New Business:</u> The Board discussed the upcoming Surfside Colony annual meeting, handicap signage and access, and ventilation of the computer room.

Adjournment: There being no further business to be brought before the Board, Director Kriss moved to adjourn the meeting at 7:32 p.m. and to schedule next month's meeting for Monday, August 20th, 2018. Secretary Winnen seconded, and the meeting was unanimously adjourned.
