Review and Possible Approval of the January 14th, 2019 General Board Meeting Minutes: After the Board reviewed the January 14th, 2019 General Board Meeting Minutes, Secretary Winnen moved for approval as presented. Director Lalonde seconded, and the motion passed unanimously.

The Clerk reported that the County Auditor-Controller's office confirmed that the District had been correctly apportioned property tax revenue in the past and current fiscal years. The Clerk presented the Annual Form 700 Statements of Economic Interests to Board members present for review and approval.
