President Mesmer led all in the Pledge of Allegiance and called the meeting to order at 6:30 p.m.

Community Input: K.C. Coultrup of Surfside Colony, Ltd. updated the Board members of the status of current projects in progress. The A-Row Street Replacement project was underway, in conjunction with the Sunset Beach Sanitary District's sewer lateral project. The goal is for the project to be completed by Memorial Day weekend. In regards to the security camera project, it was decided to postpone installation until next fiscal year due to restrictions from COVID-19 lockdown.

Review and Possible Approval of the March 16th, 2020 General Board Meeting Minutes: After the Board reviewed the March 16th, 2020 General Board Meeting Minutes, Director Johnson moved for approval as presented. Director Amundson seconded, and the motion passed unanimously.

<u>Current Bills</u>: Clerk Montana presented check #'s 3620-3623 in the amount of \$79,920.00 for review and signature, consisting of \$36,000.00 for Project Costs as approved at last month's meeting and \$43,920.00 for the monthly Security and Maintenance billing and general administrative expenses. Checks were approved and signed as presented.

Clerk's Report, Fund Balance and Review of Trial Balance: Clerk Montana reported the fund balance as of April 22nd, 2020 to be \$1,183,823, and reviewed the trial balance with the Board.

Board Authorization of District President and Alternate to Vote in LAFCO Election: Director Johnson moved to authorize President Paul Mesmer to vote in the LAFCO Orange County Special District Selection Committee election as the regular voting member, and Gayle Mueller-Winnen, Secretary, as the alternate voting member. Director Amundson seconded, and the motion passed unanimously.
