Review and Possible Approval of the July 18th, 2016 General Board Meeting Minutes: After the Board reviewed the July 18th, 2016 General Board Meeting Minutes, Director Mesmer moved for approval as presented. Director Farrell seconded, and the motion passed unanimously.
