The Special Board meeting had been called in order to review and possibly change insurance carriers for the General Liability, Errors and Omissions Policy for the District's Board of Directors.

Board members present reviewed the proposed coverages and premium costs from both Dreckman Huggins and SDRMA. Dreckman Huggins' policy was priced at \$6,080 for \$1,000,000 of coverage and a \$5,000 deductible. SDRMA's policy was priced at \$4,474.06 for \$2,500,000 of coverage with no deductible.
